<b>May 10, 2024</b>	Last Day Registrars Shall Accept an Application for Absentee Ballot by Mail
<b>May 11, 2024</b>	Mandatory Saturday Advanced In-Person Voting 9:00 a.m.- 5:00 p.m.
<b>May 17, 2024</b>	Last Day of Advanced In-Person Voting 9:00 a.m. -5:00 p.m.
<b>May 21, 2024</b>	Last Day Registrars Shall Accept an Absentee Ballot By Mail by 7:00 p.m.

**All Advanced In-Person Voting** will take place Monday through Friday (except for mandatory Saturday voting) from 9:00 am -5:00 pm., at the Jenkins County Courthouse 611 East Winthrope Avenue, Millen, Georgia 30442.
